– Documented hospitalization or illness of self, child, or parent (if self, must include dates and medical records as to your readiness to return to school)

– Military withdrawal (include documentation from your commanding officer)

– Victim of a crime or unexpected disaster (include copies of police report, third-party letters, etc.)

– For other circumstances not addressed in the above categories, submit a written statement that explains your situation and include supporting documentation.
