## B. IDENTITY

To complete the verification process, you must appear in person at the New York Institute of Technology Financial Aid office and verify your identity by presenting a valid, unexpired government-issued photo identification (ID), such as, but not limited to a driver's license, or other state-issued photo ID, or passport. New York Tech will maintain a copy of your ID that is annotated with the date it was received and the name of the official at the institution authorized to collect your ID.

If you cannot appear in person to present your identification, you may submit a copy of your identification document that is acknowledged in a notary statement or that is presented to a notary by completing an Identity Verification form, which is available on our website at <https://www.nyit.edu/admissions/costs-and-aid/financial-aid/policies-and-forms/>. You may also schedule an appointment for a video call (Zoom) to present your identification.
